## Home Improvement Reminders

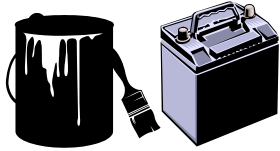

Such actions are subject to assessments of up to \$50.00 per incident.

## LEASH LAWS

There have been reports of homeowners walking their dog without a leash. It is a Fairfax County ordinance that all dogs be on a leash, cord or chain when off the owners' property.

If anyone observes an unrestricted dog, whether it is aggressive or not; they should call the police non-emergency number 703-691-2131, an animal control officer or police officer will be dispatched to the scene.
